According to official documents, in 2005 Hawken pled guilty to Child Molestation 3rd degree in Cowlitz County. He was also convicted of Tampering With A Witness at the same time. Hawken (age 27) had sexual contact with a known three-year-old female. While in jail Hawken spoke to his wife and tried to get her to falsify her testimony and/or withhold testimony related to his whereabouts at the time of the incident. Hawken was found to be non-amenable to treatment because he denied his offense and refused treatment. Hawken took a deferred prosecution on two counts of Assault 4 DV. ON May 29, 2008 Mr. Hawken pled guilty in Cowlitz County Superior Court to Rape of a Child in the First Degree. Mr. Hawken, 29yo had sexual intercourse with the 9yo familial female victim.

The Cowlitz County Sheriff's Office is releasing this information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision State v. Ward, which authorizes law enforcement agencies to inform the public of a sex offender release when, at the discretion of the Agency and the Risk Assessment Committee, the information will enhance public safety and protection. The sex offender listed has served the sentence imposed by the courts and has advised the Cowlitz County Sheriff's Office of their address. This Registered Offender is not wanted at this time. This notification is not intended to increase fear; rather it is our belief that an informed public is a safer public. Law enforcement agencies have no legal authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live anywhere. Citizen abuse of this information to threaten or harass registered sex offenders will not be tolerated. Such abuse could potentially end law enforcement's ability to do community notifications. The Cowlitz County Sheriff's Office can provide useful information on personal safety. SOME SUGGESTIONS FOR SELF-PROTECTION:

1. You and your children should be continually aware of who is around you. If they are unfamiliar to you, don't put yourself in jeopardy.
2. Be aware of where your children are. Try to establish a time share child watching effort for children playing in the neighborhood.
3. Establish neighborhood safe havens for children as well as adults.
4. Urge your children to play in the area of other children, and caution them to not go anywhere with strangers.
5. Plan methods of escape, routes of escape and methods of self protection
