According to official documents on 10/24/07 Jason Allen Londo in Cowlitz County Superior Court pled guilty to 4 counts of Communicating W/Minor for Immoral Purposes. On 09/29/94 he pled guilty as a juvenile to (3) Counts of Rape of a Child in the 1st Degree and Child Molestation in the 1st Degree. In the Juvenile Offense the victims were both familial and known victims. The ages of the victims were 3 yoa to 5 yoa. Mr. Londo fondled the male victim's penises and had oral contact with them. Mr. Londo fondled the female victim's vaginia. On 06/10/99 Mr. Londo was relieved of the Duty to Register for the Juvenile Offenses. Mr. Londo 25yo communicated with a Detective on the internet posing to be a 13yo female. Mr. Londo's conversation turned sexual telling the victim what sexual acts he wanted to perform on her. He offered his telephone number and offered to meet her. He also set up a web cam where the victim observed Londo naked and masturbating. Mr. Londo participated in treatment as a Juvenile but decline treatment as an adult.

The Longview Police Department is releasing this information pursuant to RCW 4.24.550 and the Washington State Supreme Court decision State v. Ward, which authorizes law enforcement agencies to inform the public of a sex offender release when, at the discretion of the Agency and the Risk Assessment Committee, the information will enhance public safety and protection. The sex offender listed has served the sentence imposed by the courts and has advised the Longview Police Dept. and the Cowlitz County Sheriff's Office of their address. This Registered Offender is not wanted at this time. This notification is not intended to increase fear; rather it is our belief that an informed public is a safer public. Law enforcement agencies have no legal authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live anywhere. Citizen abuse of this information to threaten or harass registered sex offenders will not be tolerated. Such abuse could potentially end law enforcement's ability to do community notifications. The Longview Police Dept. can provide useful information on personal safety. SOME SUGGESTIONS FOR SELF-PROTECTION:

1. You and your children should be continually aware of who is around you. If they are unfamiliar to you, don't put yourself in jeopardy.
2. Be aware of where your children are. Try to establish a time share child watching effort for children playing in the neighborhood.
3. Establish neighborhood safe havens for children as well as adults.
4. Urge your children to play in the area of other children, and caution them to not go anywhere with strangers.
5. Plan methods of escape, routes of escape and methods of self protection
